The Meeting on “Thoothukudi-Vision 2025” was held on 20.12.2011 at 12.30 P.M in Sippi Koodam, Collectorate, Thoothukudi under the Chairmanship of the District Collector, Thoothukudi.

Minutes of the Meeting are as follows :

1.V.O.C. Port Trust :

The Chief Engineer, V.O.C. Port Trust expressed that the National Maritime Projects Phases I and II would enable the port to increase the tonnages handled at the Port to about 85 million tones by 2012 and 130 million tones by 2025. If the infrastructure is developed so that it can

handle post-panamax vessels, container traffic can increase from the current 450,000 TEUs to 2.31 million TEUs by 2015 and 3.72 million TEUs by 2020. This can be forecasted at 5 million TEUs per annum by 2025.

2. Vagaikulam Airport:

The Airport Officer was requested to take essential steps to upgrade the airport to international standard in order to meet the needs of public in 2025.

3. Thoothukudi Corporation:

The Commissioner, Thoothukudi Corporation was requested to speed up and complete the Development of 'Buckle odai' and to prepare a master plan to provide the basic amenities by considering the growing needs of people in 2025.

He was also instructed to prepare a detailed project report for "Fourth Pipe Line" project so that to meet the drinking water supply requirement in future and "Park Improvement Scheme" to provide infrastructure facilities at the parks situated in Thoothukudi Corporation.

4. Improvement of Roads:

The Divisional Engineer, Highways, Thoothukudi was requested to prepare the detailed project report for providing four laning at Ettayapuram road to Thoothukudi new bus stand and Thoothukudi - Palayamkottai road(Old Bus stand to FCI Godown).

He was also instructed to prepare a proposal for "Improvement of Thoothukudi to Maniyachi road" which runs about 33 K.M.

5. Tourism Projects:

The Tourist Officer, Tirunelveli was requested

- 1.To get proposals from the Joint Commissioner, HR&CE, Tiruchendur for formation of "Theme Park" at Tiruchendur.

2.To co-ordinate with the Commissioner, Thoothukudi Corporation and to prepare the project proposal for construction of boat house at Roche Park and Improvement of Nehru Park at the earliest.

6. Fly Over Bridge:

The Divisional Engineer, Highways, Thoothukudi was requested to prepare the detailed project report for construction of fly over bridge near VVD signal in Thoothukudi.
